## WARNING ON IMMUNE SUPPRESSING TECHNOLOGY: EFFECT ON VACCINATION

Dear Mr Hunt,

A question for you Mr Hunt: do you have any health studies on millimetre wave health effects that you can provide for me that disagree with the outcomes of the two Russian studies referred to below, and included in hard copy in this presentation?

In particular, do you have any health studies that would disagree with the 1978 Russian study outcomes showing a massive decrease in efficacy of vaccines on mammalian physiology under the influence of millimetre waves?

Included in this package are copies of original documents of two Russian studies from 1977 and 1978/9 conducted on humans and animals under the exposure to millimetre wave frequencies.

A précis of the documents by South Australian Dr Trevor Douglas (Douglas Blood Microscopy Centre) is also included. These précis by Dr Douglas will be identified by the heading "Précis of paper by Zalyubovskaya 1977 and 1978", paper 1 or 2.

These studies were implemented after numerous previously healthy factory workers in Russia servicing "high frequency" (millimetre wave producing) generators began to suffer debilitating health events.

These factory workers and controls were examined over a three year period,

The rats in the animal studies, however, were exposed to a mere 15 minutes per day over 60 days of millimetre wave exposure to yield the results of profound damage to the immune function and morphology of the rat physiology.

I highlight on page 12 of the 1978/9 study the section on vaccination.

Vaccinated animals exposed to millimetre wave had a massive 30% to 40% increase in mortality (death) when exposed to the specific infectious agent that they received the vaccine for.

The millimetre wave frequencies studied above are within the same frequencies being deployed now, or soon across Australia and known under the banner of 5G.

These Russian studies from the 70s indicate that millimetre wave exposure has a swift and damaging effect on the immune system. Why would not the exact same frequencies studied in Russia in the 70's have the exact same effects on Australian citizens now, more than four decades later?

Many of our citizens utilizing 5G appliances will experience much longer exposure times, perhaps 24/7, 365 days a year, than the Russian factory workers.

#### THE SPECIFIC DAMAGING FREQUENCY OF 60 GHz.

Millimetre wave 5G will encompass a number of different frequencies.

One frequency which will be employed is that of 60 Ghz (Gigahertz)

This particular bandwidth of 5G will be sought after because it will be a free frequency.

The telecommunication industries favour this frequency because as the millimetre waves are absorbed by oxygen (a unique property of 60 GHz) interference with other frequencies being used in the local environment is avoided.

However this very same property of the millimetre waves' frequency band is that wave energy being absorbed by oxygen (up to 98%) makes it potentially highly dangerous to the body of both humans and animals.

The oxygen molecule is excited to spin faster as it absorbs the millimetre wave of 60 GHz. This in turn, within the body, prevents the oxygen being uptaken by haemoglobin. This can cause hypoxic symptoms such as shortness of breath, bluing of the skin, collapse and death.

This process of chemical and metabolic effects on the human body under the influence of electro magnetic radiation is explained in Vladimir N Binhi s' book, "Magnetobiology Underlying Physical Problems, Academic Press 2002."

I have also included a text by Harmonix Corporation to demonstrate that the industry admits this property of 60GHz, to be absorbed by oxygen.

#### FURTHER POINTS TO CONSIDER: CIA CLASSIFIED

The 1977 study was classified for over 4 decades by the CIA, so the American government must have found the study results important and in its interests to keep it from the public domain.

The Russian study scientists had no known conflict of interest, there was no incentive for any corporation to benefit from the outcomes of these studies.

There was no trillion dollar telecommunications industry such as we see today to drive any desired outcome.

Nor were these the only studies of their kind. Russia, Poland and Czechoslovakia, as well as the US, had been studying the effects of EMR on humans and animals over a decade earlier.

One interesting finding from the numerous studies done in these decades (50s' through 70s') was the similar effects that some EMR frequencies had in common with the effects chemical poisoning.

Symptoms of EMR exposure were often almost indistinguishable from those of organophosphate poisoning.

In a US government study, at 2.45 GHz Rats exposed for 7 hours a day (.5mW/cm<sup>2</sup>) for 90 days showed blood cholinesterase inhibition, which also happens with organophosphate poisoning.

Some symptoms of organophosphate poisoning include: chest pain, breathing problems, headache increased sweating, nausea, muscle weakness, but almost the exact same symptoms could be found to be caused by EMR exposure.

Interestingly, loss of sense of smell (anosmia) can be another symptom of EMR exposure (reference Prague Marha, Karel Biological effects and health implications of Microwave Radiation 1970).

However, despite all these well-studied health effects of millimetre waves and other frequencies of EMR, which could well complicate the correct diagnosis of other diseases, virus, bacteria or a host of poisons, no recent studies have been carried out on the 5G (millimetre wave frequencies.) How these would act in concert with other EMR frequencies or act in the presence of poisons including air pollution, or most pertinently have an effect on the action of viruses.

## NO STUDIES AND ZERO DOLLARS

In Feb 2019 US Senator Richard Blumenthal, at a hearing of the US Senate Commerce, Science and Transport committee got an admission from the telecommunications industry lobbyists and representatives that no money had been put towards studying the health implications of 5G.

Two months earlier at a press conference that same Senator stated "the stark simple fact is the health hazards are unknown and unstudied and that is a sign of neglect and disregard on the part of the Federal Communications Commission that seems unacceptable."

It is quite clear from the outcomes of the Russian studies that this form of millimetre wave frequency 5G will form a serious health risk by potentially lowering the immune system of all Australian citizens exposed.

## THE HYPOCRACY OF THE CURRENT HEALTH (ie Covid) "CRISIS" IN AUSTRALIA.

As I write this Prime Minister Scott Morrison is talking of mandating the, as yet in preparation only, C19 vaccine.

This vaccine, skipping all animal trials and fast tracked to meet the demands of a politic hungry for a symbolic "fix" or silver bullet for the medical and political mismanagement of Covid 19, will just become another health disaster.

Crimes against humanity are already being committed, I believe, in this country and rolling out any untested vaccine with no known long term side effects and attempting to take away peoples right to their own body through coercive tactics to force people to be vaccinated will become, I believe another element in this crime.

The "vaccine" will have nothing to do with health, rather it will be used as a symbolic gesture, a passport, another bargaining chip of red tape to further control our citizens and deny basic human rights.

It is clear that the Russian study above from 1978 studying the effect on vaccinated rats exposed to 5G (millimetre wave) and the negative health outcomes that ensued, demonstrate the importance of these animal studies.

Would it have been ethical for the Russian scientists to vaccinate and then purposefully infect HUMAN test subjects with anatoxins with and without millimetre wave exposure?

Yet as the C19 vaccine has had no animal trials, skipping straight to humans, we will be doing just that, putting vaccinated humans out in an environment with an unknown exposure to millimetre waves (5G).

Also a depleted immune response due to 5G exposure may only be one of the problems with a fast tracked vaccine.

In 2012, 30 vaccines were prepared in order to address the Sars virus (which was never declared "pandemic").

Four of the best went to animal trials with ferrets being inoculated with an RNA vaccine. A strong and seemingly positive immune response was elicited by increased antibodies in the ferrets.

However when released into the natural environment, when exposed to the "wild" virus, ALL the ferrets died.

What happened was called a "paradoxical immune response" where a seemingly strong antibody count actually worked against the body, killing all the test animals.

So the vaccine was scrapped.

Without animal trials in a C19 vaccine and without knowing the effects of millimetre wave (5G) on vaccinated animals, any government attempting to release this vaccine to the public, let alone attempting to mandate it, will be negligent in the extreme.

So I consider it a complete travesty of, medical, scientific, and health protocols that BOTH this new C19 vaccine and the Millimetre wave technology (5G) are being rolled out in tandem, virtually untested.
