## WARNING

**This email contains information that some people may find distressing.**

It has come to my attention that the Federal Government is planning on rolling out mandatory COVID-19 vaccinations throughout Australia early in the New Year. This claim is based upon what our Prime Minister stated in the media last August:

Regardless of whether the government claim that the vaccinations "...will not be mandatory" (or not), they are about to establish a national database that will identify those Australians who have had COVID-19 vaccinations and those who have not.

Despite that, the [United States Food and Drug Administration issued a](#) document (page 16) listing the possible adverse side effects the COVID-19 vaccines are likely to impact upon those vaccinated.

Given that the [Australian Government has spent “...more than \\$3.2 Billion” on COVID-19 vaccines](#), every Australian should be concerned that if anyone refuses to have a vaccination, the following 'worst-case' scenario **MAY** involve:

- An *authorised bio-security officer* will knock on your door to advise you he or she has come to vaccinate you, or to transport you and others in your house to a facility to have your free COVID-19 vaccination.

- The officer may possibly enter your home to ascertain the number and names of the people present, supported by the police.
- If you and other family members refuse the vaccination, each will likely be taken to various detainment facilities in handcuffs for each one to reconsider their refusal to comply with the order.
- Young children may be placed in the care of Department of Human Services personnel.
- At this point, you would be considered a 'criminal' for refusing to obey an *authorized bio-security officer's* direction.
- If you continue to refuse the vaccination in the first few days of being detained, it is likely you will be taken to a much larger facility to await a trial. The period until that occurs could be weeks or months.
- Once before a judge, he or she will decide if you are in breach of the Bio Security Act. The judge will then decide:
  - What degree the fine may be (up to [\\$66,600 per household member](#) who refuses)
  - What term of imprisonment will be imposed (up to 5-years).
- If each household member has chosen to refuse the vaccination, the fines must then be paid.
- If 2 adults and 2 children are each fined the maximum amount, this could amount to \$250,000.
- If the fines are unable to be paid, the government is likely to confiscate the home and sell it to recover the fines plus the costs from the sale. Meanwhile, each individual would remain in jail for the period of their sentence.

This very grim picture evolves from what is written in Federal Government legislation. This is because in the midst of a (supposed) COVID-19 pandemic, government people will claim that no one is allowed an exemption from the vaccination—just as no one is allowed exemptions from wearing masks in public despite being fit and healthy and non-symptomatic of any influenza or CV-19 virus.

### **Will you engage in this Email Campaign?**

To discover if the politicians that govern our affairs are aware of this — and are especially aware of the dangers associated with the types of *experimental* vaccines being procured, accompanying this attachment is **an email template** that you can fill out and send to your Federal and State politicians to see how concerned they really are about this matter; or whether they support this type of draconian policy.

In this, rather than put before them speculative language contained in the scenario above, it is best to stay with facts alone to see how each politician responds. **These facts are in the email template** and are accompanied with links that you should check for yourself.

Therefore, this email aims to encourage you to read everything presented here and once informed, copy and paste the entire email **into your own email system** (together with the two attachments — **Attachment to Politician** and **Concerned Lawyers Network**) and send these emails off to as many politicians as you can — particularly those who represent you in parliament — both State and Federal; with each of the politicians requiring an individual email.

If you don't have the time email each member, send an email to your local member in both the Federal and State governments.

### **Procedure**

1. **Copy and paste the text** in the *Word* template into a New email.
2. **Copy and paste the title** of the email (say) '*The Draconian Nature of Forthcoming COVID-19 (Forced) Vaccinations*' into your New email heading - or write your own.
3. **Save the attached files** (*Attachment to Politician* and *Concerned Lawyers Network* documents) to your hard drive. Then attach a copy of these two files to your New email.
4. **Search for the contact details of your politicians** in both Federal and State jurisdictions, as identified in the attached document **<Federal and State electorate links>**

Some of these politicians may not make their email addresses readily available. You may have to phone their office or use other means to find this out.

5. **Type your own contact details** into your New email.
6. **Type the contact details of your first politician** at the top of your New email.
7. **Type the politician's name** after the Dear Sir/Madam intro.
8. **Type your name and email address** at the end of your New email.
9. **Copy and paste the email address** of the first politician into the "To" box for sending.
10. Check your New email is good to go by reading it through, and then **hit the Send button**.
11. **Repeat the above procedure** for the remaining politicians.

12. If after 1 week has expired and (possibly) nothing has been heard from some, telephone their office and demand that they provide answers to your questions.
13. If your representatives refuse to respond, consider using other means to obtain an appropriate response.

#### **IMPORTANT**

**Please ensure the name and email address of the person who sent you this email HAS BEEN REMOVED BEFORE SENDING.** This is to ensure that any government official cannot claim that one individual started this email-writing campaign as an act of 'Incitement' that might then allow the politicians to justify their refusal to respond.

It is **NOT recommended** that anyone place this email or the attachments on any **social media platforms** (Facebook, Twitter, etc.), as doing this could allow these platforms to place a ban on what is posted and thereby undermine the legitimacy of others using email process to contact their politicians.

**Please read ALL the attachments.** Some are quite long, but from these you will begin to realize there are serious legal issues associated with COVID-19 and everything else written here that ALL Australians will have to deal with very soon.
